### Timeline of Activities To-Date

- SCAQMD Rule 1469 over 2 years of negotiations, MFASC costs exceeded \$650,000
  - Result workable rule for industry, supported by CARB & NGO's
- CARB Technical Work Group Meetings 7 thus far, first held on September 11, 2020 - online only, none in person
- NASF Symposium for CARB March 3, 2021
- Informal Discussions numerous throughout past 2 years with CARB board members, officials, staff, SCAQMD, allies including:
  - Boeing, United Airlines, Small Business Alliance, California Metals Coalition, Aerospace and Defense Forum, Aluminum Anodizing Council, CCEEB, American Motorcyclist Association, Rod Shows, & others
- 2021 Site Tours Sherm's Plating, K&L Anodizing, Hawker Pacific, Valley Chrome Plating
- Proposed Regulatory Language 1<sup>st</sup> draft dated May 26, 2021

## Current CARB Proposal CrVI ATCM

- Hexavalent Chromium Phase-out
  - Ban on New Facilities
    - January 1, 2024
  - Ban on Increasing Amp Hours at Existing Facilities
    - January 1, 2024
  - Ban on Decorative \ Functional Plating
    - January 1, 2026
    - 1 -year extension if needed to deal with delays in the transition
  - Ban on Functional Hard Chrome Plating
     & Chromic Acid Anodizing
    - January 1, 2039
    - Two technology reviews in the interim



#### MFA Concerns

ATCM should be an emission-based rule rather than bans

Ban on decorative \ functional CrVI plating

Does not change customer demands

Insufficient time to transition

Strands assets

Does not balance benefits and costs of update

Prohibition on new facilities & permits expanding amp hours at existing facilities after January 1, 2024

Ban on hard CrVI plating and chromic acid anodizing

Stranded assets after Rule 1469

Major uncertainty for aerospace and defense supply chain industry

Prohibition against expanding operations

Source testing should be once every 6 years [like SCAQMD Rule 1469] vs 2 years in current CARB proposal

No off-ramp[s]
